

Asda Over 50s Life Cover

Declaration and Consent

Please note you only need to read and accept this declaration if you have chosen the Funeral Benefit Option.

- I agree to charge the Asda Over 50s Life Cover plan which is stated above to Dignity Funerals Limited ("Dignity") and understand that the cash sum from my plan will be paid to Dignity.
- In return for this 'charge' Dignity agrees to provide Funeral Services up to the cash sum of my plan, plus an additional contribution of £300. I understand that if the cost of the Funeral Services is greater than the cash sum payable from my plan, plus the £300 contribution from Dignity, my Personal Representatives will need to pay the outstanding balance directly to the Dignity Funeral Director at the time of my funeral. I also understand that if the cost of the Funeral Services is less than the cash sum from my plan plus the £300 contribution from Dignity, the balance will be paid to my estate by LV=.
- I understand that a Dignity Funeral Director must be used to conduct my Funeral and that Dignity will only be obliged to provide the Funeral Benefit Option where it is able to rely on its 'charge' over my plan. I understand that I am only able to 'charge' my plan to Dignity where there are no other charges, assignments or trust arrangements affecting it. I can confirm that there are none and that I will not enter into any.
- I also understand that I (or my Personal Representatives following my death) may cancel this arrangement at any time before Dignity has been instructed to provide funeral services. If I (or my Personal Representatives following my death) choose to cancel this arrangement, Dignity will release this charge and notify LV= of the release.
- I agree that LV= may pass on my personal information to Dignity for the purpose of processing and administering the Funeral Benefit Option. I have read the enclosed materials and I am aware that this agreement is made subject to the laws of England and Wales.

I confirm that I have read the above declaration and consent, and have been advised to read the information on the Funeral Benefit option. I agree that by accepting this declaration and consent that I am bound by it.
